## Addendum to Seller Disclosure

There was a small roof leak in study (near window) that was due to the downspouts being clogged.

We cleaned out the gutters and unclogged the downspout and drain line. Went through some substantial rains after that and no further leaks detected.

Additionally, the basement interior wall (in rear of basement) had some water damage due to the downspouts being clogged. After we repaired the downspout clog, we removed the drywall, added drylok waterproofing, reframed the wall and added new drywall.

The wall was left open for approx 2 months before we added the new framing and drywall. During that period, there were some substantial rains and we never had any other water issues in basement.
